1 General Overview

1.1 What is the Ghana Music Xperience (GMX) Music Streaming Platform?

Being a dedicated music platform for Ghanaian musicians, it has additional features that enables artistes to sell their music and merchandise through the web portal as well as publish events.

11 Addressing Confusion About the Launch

Certainly. Initially, the Ghana Music Rights Organization (GHAMRO) planned to launch its new tools for monitoring music usage and copyrights in the industry before the introduction of the GMX Music Streaming Platform. However, since the necessary consultations, licenses, and regulatory approvals for the GHAMRO tools were not yet finalized, we decided to postpone their launch. Despite this adjustment, the launch of the GMX music streaming app occurred on 30 October 2024. Once all required permits, regulatory requirements, and consultations are completed, we will proceed with launching the GHAMRO tools. This change in the launch schedule may have caused some confusion, but to clarify: the GMX Music Streaming platform launch has taken place, while the GHAMRO tools will be introduced at a later date.

The GMX Music Streaming Platform is a private-sector project that operates with support from the government. While the platform is developed and managed by private entities, the government plays a significant role by providing regulatory assistance, and supporting initiatives to combat music piracy. The GHAMRO Monitoring Platform, on the other hand, operates behind the scenes to ensure that all music usage—across radio stations, TV channels, other streaming services, and public venues—is accurately tracked. This comprehensive monitoring is crucial for the fair calculation and distribution of royalties to artistes and rights holders, regardless of where their music is played. These platforms together contribute to a more transparent, fair, and thriving music industry in Ghana by addressing both the distribution of music and the protection of artistes' rights.
